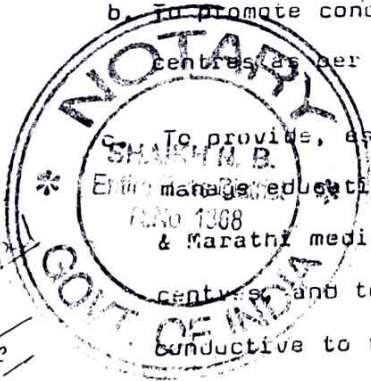
4) Objects :

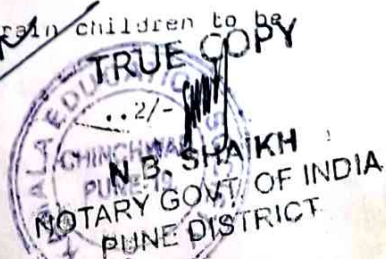

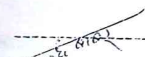

Schedule 'C'

Definitions of words used :-

- (a) **Society** :- Means the Society the names of which appears in the Memorandum of Association, & is registered under the provisions of the Societies Registration Act, 1860.
- (b) **Objects** :- Those occurring in Clause No. (4) of the Memorandum of Association.
- (c) **Member** :- Means who has been accepted as a member by the Society and who has paid his Membership subscription.
- (d) **Managing Committee** :-
 It means the Board of Trustees, Governing Council or Council on which the management of the Society is vested.

2) **Jurisdiction** :- Will be in Maharashtra State

3) **Member of the Society** is - a person who :-

- 1. Has attained the age of 18 (eighteen) years at the time of being admitted as a member of the Society.
- 2. Has accepted in writing the Constitution of the trust.
- 3. Who is desirous of becoming a member of the trust and has applied in writing to the Secretary of the Society for membership.
- 4. Has paid in full, the amount of subscription, any of the class of which he wished to become a member, and has admitted as such by the Managing Committee.

Committee.

4) Types of Members :-

1. Patrons : A person whose contribution to the permanent funds of the Society amounts to Rs. 5,000/- or more, is entitled to become a patron.

2. Trustee/Founder Member :

Trustee/Founder members are persons who being members at the inception and whose contribution to the permanent funds of the Society amount to Rs. 101/- or more, & they being Founder Members are also Life Members. There is no necessity to pay Life Membership fees separately.

3. Life Member :

Life Member means a person whose contribution to the permanent funds of the Society amounts to Rs. 3,000/- or more.

4. Temporary Member/Ordinary Member :

Temporary member is a person whose contribution to the permanent funds of the Society amounts to Rs. 50/- per year or as may be determined from time to time.

5) Seizing of Membership :-

1. The Managing Committee shall have power to remove a member if he/she is found acting prejudicially to the interest, prestige and working of the Society.
2. Resigns his membership in writing & his resignation is so accepted by the Managing Committee

3. If a member fails to attend 3 consecutive meetings of the Managing Committee without any concrete reason.

4. If a member without intimation to the President of the Society leaves India for more than 6 months or more, then his membership will be deemed to be cancelled.

6) Way of filling in Vacancy :-

If any vacancy shall occur in the Managing Committee members/ trustees on account of disqualification of a trustee or on account of vacancy due to death or resignation or if a trustee desires to be discharged or relieved from the trusteeship, then the continuing or surviving trustees shall appoint by majority any other person to be the trustee in the vacancy occurred.

7) Authorities of Society :-

The following shall be the authorities of the Society

- (1) The General Body
- (2) The Managing Committee

8) General Body :-

1. The General Body shall consist of all members.
2. The General Body shall normally meet once in every two years.
3. The meeting of the General body shall be presided over by the President or in his absence by the Vice President elected by the meeting, or in their absence a member so elected in the meeting.
4. 2/3rd of the existing members on record shall form a quorum at a meeting of the General Body.

5. If, at a duly convened meeting of the General Body, there be no quorum at the time announced for the meeting, the meeting shall be adjourned. The adjourned meeting shall be held after half an hour when no quorum is required. No subject not included on the Agenda of the meeting shall be considered at the adjourned meeting.

6. No proposal for amendment of the Constitution shall be passed by the General Body unless and until it is approved and sanctioned by the Founder Members of the General Body. No amendment shall be passed unless it is supported by 2/3 of the members present at the General Body meeting.

7. All questions before the General Body for which no higher majority is prescribed, shall be decided by simple majority of show of hands, or by ballot, if demanded by any ten or more members present. In case of equality of votes, the President/Chairman of the meeting shall have a casting vote.

8. The Secretary on the instructions of the Managing Committee and in consultation with the President shall convene the meeting of the General Body with at least 14 days clear notice. The notice of the meeting shall contain a specific agenda to be discussed at meeting.

9. The General Body at its meeting after completion of every 1 year shall elect Office Bearers, the members of the Managing Committee (i.e. Trustee).

a) Consider and approve the Annual Report of

the Society as presented by the Secretary.

- b) Consider and adopt the audited statement of accounts for the previous year.
- c) Consider the budget estimates of the Society for the following year.
- d) Consider the resolutions and amendments, referred to it by the Managing Committee or by the member of the Society.
- e) Appoint Auditors for the ensuing year.
- f) Transact such other business as may be brought forward with permission of the President.
- f) To elect Managing Committee.

9) Managing Committee :- Meeting, Notice, & Quorum :

- a) The Managing Committee shall consist of Seven (7) members, who all shall be the Trustees.
- b) The President shall preside at all the meetings of the Managing Committee. In this absence, the Managing Committee shall elect one of its member to preside the meeting.
- c) 1/4 members shall form a quorum at the meeting of the Managing Committee. Without quorum, no business shall be transacted.
- d) All questions before the Managing Committee shall be decided by simple majority of votes taken by show of hands.

In case of equality of votes, the President of the meeting shall be entitled to a casting vote.

- e) The Managing Committee shall meet once in every 3 months.
- f) Notice of Managing Committee meetings shall be sent 7 clear days in advance before the meeting (by Ordinary Post).

10) Period of Managing Committee :

The Following shall be the Office Bearers of the Managing Committee, and they will hold office for 5 years, but shall be re-eligible for election.

- (i) President ii) Secretary
(iii) Treasurer

12) Powers of Managing Committee :

1. To frame regulations consistent with this Constitution for -
 - (a) The conduct of its business and
 - (b) The conduct of its meeting and
 - (c) To manage the affairs of the Society
2. To solicit, obtain and/or accept subscriptions, donations, grants, gifts, bequests, trusts from any person, firm, corporation or institutions or a like-wise body.
3. To hold the movable and immovable properties of the Society, and to administer its funds.
4. To consider and recommend for adoption by the General Body the annual budgetary provision for the coming year of the Society.
5. To prepare the draft of the annual reports and financial statements of the Society, and recommend the same to the General Body for their sanctions, and to arrange for its publication.
6. To consider and sanction proposals for extra-expenditure.
7. To construct, maintain, extend, improve, repair alter, enlarge, modify any house buildings or such type of work, necessary or convenient for the purpose of the Society.

8. To enter into, vary, carry out or cancel contract on behalf of the Society.

To take steps with a view to preventing a member or any other employee from doing anything or acting in any manner or performing an act of commission or omission detrimental to the interest of the Society.

10. To fill vacancies in the Managing Committee caused by death, resignation or absence without leave of a member or members for three consecutive meetings. But failure to fill in such vacancy or vacancies shall not during the interval vitiate the proceedings and affairs of the Managing Committee which shall be discharged by the remaining members of the Managing Committee.

11. To consider and if thought fit, sanction proposals for the appointment of needs of institutions, and members of establishments in each institution.

12. To appoint, confirm, promote or terminate the services of the teaching and non-teaching staff.

13. To make regulations for the award of scholarship and prizes in the Society's institution.

14. To fix the salaries and allowances to be paid or made to the employees of the Society, in its various institutions.

15. To appoint a Committee or a 'Advisory Board' of the said Society.

To amalgamate with any other Society, institution or association having similar or in part

similar to the objects of the Society.

17. Generally to do all such acts and things as may be necessary or desirable in the interest of the Society whether they are expressly provided in the rules or not.

12) Provision for loan & investment :

1. To raise loans, if necessary, on the security of the movable or immovable properties of the Society.
2. To open, invest and operate all accounts of any description with any Nationalised or Co-operative bank and to invest and deal with any money of the Society not immediately required for any of its objects under Section 35 of the Bombay Public Trust Act, 1950.

13) Provision for purchase & Sell of immovable property :

1. To acquire by gift, purchase, exchange, lease or hire or otherwise any lands, buildings, assessments, rights of any property, movable and / or immovable and any estate or interest for the Society.
2. To purchase, take on lease or otherwise acquire or to give its property on lease or hire as may be deemed necessary or convenient.
3. To sell, dispose off any property or any part thereof as may be considered necessary or convenient in the best interest of the Society.

4) Duties of Office Bearers :

1. President :

- a. To provide over and conduct the General

Body Meetings, and the meetings of the Managing Committee.

- b. To convene the Special meetings on requisition.
- c. To decide all questions by majority of votes.
- d. To take any action or to suggest any proposal which he deems fit and proper in the interest of the Society.
- e. The right to call any meeting.
- f. To do all acts in order to promote the general welfare of the Society.

2) Secretary :

- a. To convene all meetings of the Managing Committee and the General Body as provided in the rules.
- b. To write minutes of the meetings.
- c. To carry on correspondence for the Managing Committee and General body in consultation with the President.
- d. To arrange and keep the records of the Society up-to-date.
- e. To keep and maintain a list of the properties of the Society.
- f. To maintain the General Registers of the members of the Society.
- g. To implement the regulations of the General Body and the Managing Committee.

To correspond on behalf of the Society & represent the Society.

represent the Society in all legal matters by and against the Society and to execute legal

documents for the Society, in consultation with the Managing Committee.

- J. The Secretary being the Founder Member is appointed permanently Clause(10) of the Rules will not be applicable to him.
- K. To perform and to do all the duties in the interest of the Society as assigned to him by the General Body, and the Managing Committee of the Society.

3) Treasurer :

- a. He will be responsible for all the sums of money which are from time to time received by the Society.
- b. To see and maintain accounts of the Society and its institutions.
- c. To get the accounts of the Society audited and present the statement of accounts the Annual General Body.
- d. To present the budget to the Managing Committee for consideration and sanction.

15) Extra Ordinary / Requisition Meeting of General Body .

Such meeting shall be held at the requisition at least 1/3rd of the total number of members on roll provided that the request is made in writing to the president and state the business to be discussed. No other business shall be discussed at the Extraordinary meeting than the specific purpose for which it is being called.

Decisions shall be taken by simple majority. The President shall have a casting vote in case of a tie.

The quorum for the transaction of business shall be 2/3rd members. In the event of quorum not being present within half an hour for the time set for the meeting, the meeting shall stand adjourned, and re-assemble after half an hour. At such adjourned meeting, the rule of shall not apply, such a meeting shall take place not later than twenty one days from the receipt of notice, the requisition.

16) Voting Rights :

Every member will have the right for one vote to be exercised at the General Body meeting. All decisions will be arrived at in the Managing Committee as well as in the General Body meeting by a majority vote. In the event of a tie, the presiding person shall have the power of deciding the issue by a casting vote. Members who are in arrears of their annual subscription will not be entitled to

(a) Vote at the Annual General Body Meeting.

(b) Stand for the election of the Managing Committee

(c) Propose, second or cast votes in the election.

17) Funds :

The funds of the Societies shall consist of subscriptions and donations and such other funds received from whatever source, and the same shall be deposited in any Nationalised or co-operative bank or Public Securities approved by the Managing Committee.

The income, money and properties of the Society, in whatever manner derived, will be applied solely towards the maintenance, upkeep and improvement of the institution and for the promotion of the Society and for the promotion of all

or any of the objectives specified and no part thereof shall be paid or transferred directly or indirectly by way of dividend, bonus or otherwise howsoever by way of profit to the members of the Society, PROVIDED & howsoever that nothing herein shall prevent in good faith remuneration to any member in return for any service rendered to the Society.

The Society may establish general, special or capital funds for furtherance of the aims and objectives of the Society, and the money will be deposited in Nationalised Co-operative banks or Public Securities.

18) Accounting Year :

The accounting year of the Society shall be from 1st of April to 31st of March each year.

19) Bank Account :

The Bank accounts shall be in the name of the Society and shall be operated jointly by the Treasurer and the Secretary.

20) Change Amendment in the name and object :

To alter, extend, amend or change in the name, objectives of the Society, provisions of Sections 12 and 12A of the Societies Registration Act, 1860, will be brought in to effect.

21) Change in Rules & Regulations :

Any change to be done in the Rules and Regulations will be done by calling a special General Body meeting and 3/5th of the total number of members should be present for the said meeting, and the said change should

be accepted in the said meeting by majority.

22) List of Members :

The list of persons who are members within the meaning of Section 15 of the Societies Registration Act, 1860, will be maintained in the form of Schedule VI to the Societies Registration (Maharashtra) Rules, 1971, vide Rules 15 thereof.

23) Provision for expenses to be done on objects :

Object Nos. 1 to 4 = 70%

Object No. 5 & 6 = 10%

Object Nos. 7 = 20%

24) Dissolution :

If the Society is to be dissolved due to any reason whatsoever, then the provisions of Sec. 13 and 14 of the Societies Registration Act, 1860, will be considered.
